## Community Spotlight: *Starke...not a wilderness anymore.*



*In honor of our clients and subscribers from North Central and Central Florida—a new column, Community Spotlight.*

Here are some interesting tidbits and facts about Starke:

- The Florida Railroad, which once connected Cedar Key to Fernandina, utilized Starke as its midpoint, officially giving rise to the town of Starke in 1857.
- In 1887, the area was described as, “A wilderness, a vast unbroken pine forest, where the deer, bear, wildcat, and stealthy panther roamed at their own free will. There was not a single house, worthy of the name, only a few shanties occupied by railroad hands.”
- Timber, citrus, and cotton were the area industries. After the “Big Freeze” of 1895 and the boll weevil 20 yrs. later—strawberries became prominent and are known as, “The Sweetest This Side of Heaven.”
- **Florida State Prison**, in Starke, is Florida’s only prison that is officially called a “prison” - other like structures are called, “Correctional Institutions” or “Correctional Facilities”, if privately contracted.
- Just outside of Starke is **Florida’s National Guard Base, Camp Blanding**—the primary training site for most of the state’s military units. The movie, “G.I. Jane” with Demi Moore was also filmed there.
- **Starke is the County Seat of Bradford County**, which includes Brooker, Graham, Hampton, and Lawtey.
- Starke and Lake Butler fought over the location of the county seat of Bradford County until 1921 when the county was divided, and the western portion was renamed Union County with Lake Butler as its Seat.
- **Starke is 6.7 square miles—all of it land!**

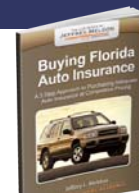

## Office Blog: *Turn signals—use them—NO EXCUSES!*

**Have you ever wondered why drivers don't use their turn signals?** If you have you're not alone. In 2005, a Response Insurance survey found that 57% of U.S. drivers surveyed consistently fail to signal when changing lanes. The number one reason cited—they're in a hurry! Subsequent reasons for not signaling are increasingly disturbing.

1. **No time.** About 42% of drivers say they don't have enough time. Really? It only takes a second to signal!
2. **Lazy.** Approximately, 23% say they are just too "lazy."
3. **Hassle.** About 17% don't signal because when they do, they forget to turn it off.
4. **Tedious.** Some 12% admit they are changing lanes too frequently to bother.
5. **Unimportant.** About 11% say it's trivial.
6. **Others Don't.** Another 8% say they don't signal because other drivers don't.
7. **Exciting.** Most shockingly, 7% say not signaling "adds excitement to driving."



**Forgoing a turn signal is not just irritating, it's illegal—and potentially fatal.** Turn signals alert motorists, bicyclists, and pedestrians of an immediate turn or lane change, while on the roadway.

As fellow motorists and an office that deals with serious injuries resulting from crashes, **we urge all motorists to signal—no excuses.** If you need a reason, just look at the statistics. **In Florida, improper passing and lane changes contributed to roughly 4,200 injuries and 42 deaths among motorists, according to the 2009 Florida Crash Reports.**

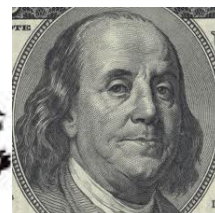
**Heads up—**Failure to use turn signals can result in a traffic violation and ticket. **In addition, if failure to properly signal is found to contribute to an accident, you could be found to be "comparatively negligent" for the accident and be held liable for your portion of fault.**

## Recent Accident Case—A picture is better than a thousand words!

**Just because you are innocent in a crash, don't be surprised when the other driver says you are at fault.** Here is a recent case:

- Our client was driving in her lane when a truck abruptly changed lanes in front of her to avoid hitting a car that had suddenly stopped in front of him. The crash resulted in serious low back injuries and surgery for our client.
- At the scene, the truck driver admitted he had changed lanes illegally. However, when he reported the crash to his employer, the story changed. To his boss, he blamed the accident on our client, saying he had completely changed lanes and the girl that hit him wasn't paying attention.
- Fortunately, the truck driver's employer sent an investigator to the scene to photograph the skid marks and the wrecked truck. Our client only had a picture of her damaged car.
- With these pictures, our accident reconstruction expert, determined that our client's story was indeed true.

### MORAL OF THE STORY

Without these pictures, it might have been difficult to prove our case. **If you are in an accident, take pictures of all the damaged vehicles at the scene, and any skid marks, or other evidence. Remember, once the vehicles are towed and the accident scene cleared, you may never get another chance to prove your case.**

## Ask Jeffrey: **What is drugged driving?**

“Drugged driving” means taking the wheel, while under the influence of any illicit, prescription, or over-the-counter drug. The problem is more serious that you may think—it has become a public health crisis. Here is the info:

- It is estimated that 20% of all crashes are attributable to driving while “drugged.” Plus, more than 16% of weekend, nighttime drivers tested positive for illegal, prescription, or over-the-counter medications, according to a 2007 National Highway Traffic Safety Administration report.
- Drugs affect the brain and central nervous system, resulting in possible disorientation, drowsiness, memory loss, or “sleep driving.” Drugs are especially dangerous for drivers when mixed with alcohol.
- Teens are most at risk. Studies show that teens who reported having conversations with their parents about alcohol and drugs were more likely to stay drug-free.
- Older drivers are extremely susceptible to medication side effects because they often mix multiple medications. Older drivers should consult their pharmacist or doctor before driving. Look on the label for warnings: “May cause drowsiness” or “Do not operate machinery while taking this medication.”

**Remember, DUI stands for Driving Under the Influence.** A DUI charge does not necessarily imply alcohol consumption. A person can be “under the influence” of legal or illegal drugs or anything that causes a persons’ normal faculties to be impaired, including alcohol.  
**Drugged driving can result in a DUI arrest, carrying the same long term consequences.**
