# Office Blog: Be Safe on our Waterways—5 Florida Boating Basics

Summer months are often the most dangerous for Florida's waterways. Already this year, 18 people have been killed in boating accidents, according to the Florida Fish and Wildlife Conservation Commission (FWC). In 2010, there were 668 boating accidents, resulting in 79 deaths. About 66% of those involved in accidents had no formal boater education training.

To help keep our citizens and visitors safe on the water, here are five of Florida's boating basics:

- 1. **Boating Under the Influence (BUI):** Florida's DUI laws apply to boating. It is illegal to operate a watercraft with a blood alcohol concentration (BAC) of .08% or higher (or .02% for under 21 years of age) or operate a boat while impaired by drugs or alcohol.
- 2. **Boater Education and I.D.:** To operate a boat of 10 horsepower or more, if you were born on or after January 1, 1988, you must successfully complete an approved boater's education course and obtain an I.D. from the FWC (effective January 1, 2010). See the FWC for exceptions.
- 3. **Tourist Boat Rentals:** A non-Florida resident must comply with Florida boater and education requirements or equivalent. Proof of successful completion of an equivalent out-of-state course, such as NASBLA approved, may suffice.
- 4. Minimum Age of Operation: A personal watercraft operator must be at least 14 years of age.
- 5. **Personal Flotation Devices (PFDs):** There must be at least one PFD (Type I, II, or III, and USGS approved) for vessels 25.9 feet and less, including canoes and kayaks. Children under six years of age must wear a PFD. In federal waters off Florida's coast, children 13 years and under must wear a PFD. Vessels 16 feet or longer must also carry a Type IV "throw-able" PDF. Water skiers and anyone towed behind a boat must wear a PFD.

### **Interesting Case of the Month—Workers' Compensation System Foiled**

Recently, a young woman was injured in a car accident, while on the job. She had been to two other lawyers before coming to our office. The other lawyers were only able to get her a \$25,000 offer on her claim. Plus, she was being denied the surgery that the Workers' Compensation doctor said she required.

The problem was that the Workers' Compensation adjuster was controlling the situation and was unreasonably denying her medically necessary surgery. Her prior lawyers apparently didn't know how to deal with the Workers' Compensation System.

When she came to our office, <u>I accepted the case and took control</u>. I explained that she had legal rights to get treatment and surgery, and she could also get money from the person that caused the accident.

**Ultimately, the woman's case settled for \$225,000, plus \$30,000 from Workers' Compensation.** She underwent surgery, and is feeling better. She was even able to return to work and graduated from Nursing School. She is thankful to us for helping her get her life back on track.

#### **Ask Jeffrey:** Hospital Medical Malpractice—Do I need a lawyer?

Yes. If you have a serious injury caused by medical malpractice, do not go it alone. Hire an experienced medical malpractice attorney ASAP. An experienced lawyer is necessary to be on an equal playing field and to get justice for the wrongful care that resulted in injury or death.

Occasionally, a hospital will offer an individual a quick settlement when there is a fairly obvious mistake that caused harm. They may even tell you to not hire a lawyer because attorney's fees will only reduce your settlement. Here are a few things to consider:

- Hospitals are experienced in analyzing and handling malpractice claims and settlement negotiations. Their representative knows what your claim is really worth. It is their job to know these things, but probably not yours, so you are on unequal ground.
- 2. The responsibility of the hospital's claims adjuster is to not pay fair value, rather to pay the least amount they can get away with.
- Most malpractice cases have complicated liens against your settlement by entities like Medicare, HMOs, or other private insurance companies.
- 4. Failure to pay back these liens can be a crime.
- 5. The hospital will hire a team of top notch lawyers, who specialize in malpractice defense and know all possible technicalities and strategies to get your case thrown out.
