Here are some interesting tidbits and facts about Lafayette County:

- Lafayette County was created in 1856 (pronounced "la fay et" or "la fet", not "laf ee et").
- It was named in honor of the Marquis de Lafayette, a French citizen who rendered assistance to the colonies and served with George Washington in the American Revolution.

Community Spotlight: Lafayette County—a dry county with history!

- The county is the **second least populated county in the state**, having one more resident, in the 2000 census, than Liberty County.
- Mayo is the county's only incorporated town and its County Seat, since the courthouse in New Troy burned down in 1892. New Troy is now a "ghost town."
- Lafayette County is a prohibition county, or entirely "dry."
- The Hal W. Adams Bridge, built in 1947, spans the Suwannee River. It is located three miles north of Mayo and is Florida's first suspension bridge.

Office Blog: Steps to Survive a Vehicle Recall—err on the side of repair!

While a vehicle recall is not a reason to panic, it is a time to take action. We suggest—err on the side of repair (it is free.)

Generally, automakers issue a recall because a vehicle is defective and may cause injury—or worse. <u>Last year, nearly 20</u> million vehicles were recalled in the U.S., but as many as 30% of owners failed to get the necessary repairs.

While many owners receive a recall letter in the mail, some do not. So, don't wait for a letter—your life may be at stake. Stay informed, and follow these recommendations:

- 1. If you get a letter, call the dealership. Schedule an appointment to get your vehicle evaluated and repaired as soon as possible. While not every vehicle subject to recall is affected, your vehicle could have a major, life-threatening defect. Plus, repairs are free.
- **2. Don't wait for a recall letter.** Often, there is lag time between when the media picks up on a recall and when the automaker sends out notices. If your car is showing defect symptoms, bring it to the dealer.
- **3.** Check www.Safecar.gov for recalls. The National Highway Traffic Safety Administration (NHTSA) posts all vehicle recalls for consumers. Enter your car's model, make, and year for a complete recall history. Sing up for NHTSA's recall email alerts.
- **4. Check the dealership's "bulletin."** Sometimes, cars have problems that don't necessitate a nationwide recall. In this case, an automaker will notify dealerships with "technical service bulletins" to check at the time of service. Review these with your dealership.

Common Office Question—"When will my case settle and for how much?"

To even begin to formulate an answer to the question of an individual case value or settlement time frame, there are many questions to be answered first, such as:

- How much insurance is available? A case may be worth \$100,000, but if there is only \$10,000 of insurance, probably it's worth \$10,000.
- How serious are the injures? If there is \$250,000 of insurance, and injuries are minor, the case is worth far less than the insurance.
- How much damage was done to the vehicle? This often requires pictures and investigation.
- How much are a person's medical bills and future medical bills? Medical bills can often be negotiated.
- How much past or future income was lost because of the accident? This is another factor that requires time and investigation.
- Were there any prior or preexisting medical conditions? Often preexisting conditions require consultations with medical experts.
- Who was at fault in the accident? In Florida, more than one person can be at fault in an accident and assessed a percentage of liability.
- Has Maximum Medical Improvement (MMI) been reached? Once MMI is reached, the long term affects of the crash can be assessed. However, it is very important to consult with an attorney immediately after an accident—do not wait until MMI is reached.

Ask Jeffrey: Can I legally "ride free" in Florida?

While Florida law respects a motorcycle rider's choice to "ride free" without a helmet, I urge all motorcyclists and passengers to wear state-approved safety helmets.

Since Florida's repeal of the Universal Helmet Law in 2000, the state has two helmet requirements:

- 1. A motorcycle rider that is under the age of 21 must wear a state-approved helmet.
- 2. A biker 21 or older that chooses not to wear a helmet, must carry an insurance policy providing at least \$10,000 in medical benefits.

Be aware when crossing state lines—there are 20 states and Canada that require helmet use for all motorcyclists, including our neighbors: Alabama, Georgia, Louisiana, and Mississippi.

I strongly urge all riders to carry full insurance coverage, including: Uninsured Motorists Coverage to protect themselves from another driver's carelessness; Medical Payment coverage of \$50,000; and medical insurance to protect yourself no matter who was at fault.

If in an accident while "riding free," you are three times more likely to suffer a serious brain injury than when riding with a helmet. A hospital bill for a serious head injury could cost more than \$200,000, not including rehabilitation, future medical expenses, and lost wages.
