

#### Ingredients:

- 1 (1 pound) loaf cocktail rye bread.
- 1 cup thousand island dressing.
- $1 \frac{1}{2}$  pounds deli sliced corned beef.
- 1 (16 ounce) jar sauerkraut, rinsed and well drained.
- 1 pound sliced Swiss cheese

#### **Directions:**

- Preheat the oven's broiler.
- Arrange cocktail rye slices on a baking sheet. Top each one with about 2 teaspoons of thousand island salad dressing, then fold about 1/2 slice of corned beef to fit the bread, and lay over the dressing. Place a small amount of sauerkraut over the meat, then top with 1/4slice of the Swiss cheese, or a slice about as big as the bread

Prep: 15 Min, Cook: 5 Min, Ready in: 20 Min

Broil for 3 to 5 minutes, until cheese is melted. Serve • warm

However, there were no snakes to begin with, as the Emerald Isle is surrounded by water that is too frigid for snakes to ever migrate there. The color Green is associated with St. Patrick from his use of the shamrock, but the original color was known as "St. Patrick's Blue"

# This month's topic of interest: March 2014

Each month our staff takes a number of calls from people within the North Central Florida Community. Although we aren't always able to take every case we receive. there is always an opportunity to educate others. Here's a topic worth discussing.



#### **Uninsured Motorist Insurance Coverage in** the State of Florida.

Uninsured motorist (UM) coverage provides protection of your personal finances when there is no insurance or inadequate insurance on the part of the at-fault person to compensate you for your damages resulting from an accident. This also includes protection from hit and run drivers, and protection if you are injured as a passenger in someone else's vehicle.

yourself with uninsured motorists coverage because the State of Florida only requires the other at fault driver to have Personal Injury Protection (PIP) insurance and property damage coverage( that protects the other driver if you are at fault). If you are in an accident caused by an uninsured/underinsured driver, you have the right to recover from your own insurance company, and if they refuse to pay you what you are entitled to, you can file a Civil Remedy Notice with the State of Florida and you may recover even more than your insurance policy limits. This is an important weapon to use against the wealthy and powerful insurance companies.

## Q: What type of automobile insurance is required in the state of Florida?

A: Personal Injury Protection (PIP) to pay for some of *your* medical bills and lost wages, no matter who is at fault for the accident, since Florida is a "no fault" state. Property Damage coverage of \$10K is also required to pay for the other person's property. 


