

Each month our staff takes a number of calls from people within the North Central Florida Community. Although we aren't always able to take every case we receive, there is always an opportunity to educate others. Here's a topic worth discussing.



Motorcycle Insurance Laws in Florida: Are you properly covered?

Florida has unique laws when it comes to motorcycles. In most states you have to have the same coverage on your motorcycle as you do on your car or truck. Not so in Florida. In fact, the only insurance you are required to have in Florida is \$10,000 in Medical Payments insurance if you are over 21 and want to ride without a helmet. Otherwise, you can get a motorcycle licensee without any insurance.

What is strange about this is that Motorcycle riders need high limit insurance need. even more than auto/truck driver/owners do because of the significant risk of injury.

We recommend having at least \$100,000 in Uninsured Motorist Coverage and property damage liability coverage of at least \$25,000 as well as Medical Payments Coverage of \$50,000 or more.

Since Florida has one of the highest rates of uninsured drivers in the country, the chances are that the careless driver that pulls out in front of you or runs into you and causes you serious injuries will not have adequate insurance.

Remember your auto/truck insurance policy will have an exclusion for any accidents while you are on you motorcycle so you cannot rely on this insurance policy. You need a separate motorcycle policy.

We advise that you consult your own local insurance agent for recommendations customized to your needs. Do not rely on the internet or some toll free insurance sales operator to get you the kind of motorcycle insurance you

Gainesville, FL- On February 17th, 2015 the Junior League of Gainesville's new member class partnered with the Belk department store at the Oaks Mall to hold the JUNIOR LEAGUE OF GAINESVILLE 10th Annual PACE Fashion Show benefitting the PACE Center for Girls. PACE serves as a delinquency prevention program for girls in Alachua County and statewide, while targeting the unique needs of girls ages 12 to 18 who are in need of academic skills and provides a safe and nurturing

learning environment.

Every girl at PACE sets individual educational and social goals that are focused on earning a high school diploma or GED, re-entering public school, attending college, getting vocational training, joining the military or entering the private workforce. After program completion, PACE continues to monitor each girl's educational and personal development with three years of follow-up case management.

Girls from PACE who met certain criteria set by their teachers had the opportunity to participate in the fashion show. They had their make-up done at Belk and modeled outfits of their choice for the women of the Junior League and their friends and family.

It was a special event for the PACE girls and for the entire Junior League. Funds raised at the event through a raffle and "catwalk contributor" sponsors are used for projects at PACE.
