Mother's Day The History of Mother's Day

Mother's Day is celebrated in several countries around the world including the U.S. and is celebrated on the second Sunday in the month of May, but in many other countries Mother's Day is celebrated during an entirely different time of the year. But whatever may be the date of Mother's Day around the world, the spirit is the same everywhere.

The origins of Mother's Day are attributed to different people. Many believe that two women, Julia Ward Howe and Anna Jarvis were important in establishing the tradition of Mother's Day in the

continued to be held in Boston for about ten years under her sponsorship, but died out after that. In 1907, Anna Jarvis held a private Mother's Day celebration in memory of her mother, Ann Jarvis, in Grafton, West Virginia. Anna Jarvis had organized "Mother's Day

Work Clubs" to improve health and cleanliness in the area where she lived. Anna Jarvis launched a quest for Mother's Day to be more widely recognized. Her campaign was

later financially supported by John Wanamaker, a clothing merchant from Philadelphia. In 1908, she was instrumental in arranging a service at the Andrew's Methodist Episcopal Church in Grafton, West Virginia, which was attended by 407 children and their moms. The church has now become the International Mother's Day Shrine. It is a tribute to all mothers and has been designated

as a National Historic Landmark. Mother's Day has become a day that focuses on generally recognizing mothers and mother figure roles. Mother's Day has also become an increasingly important event for businesses in recent years. This is particularly true of restaurants and businesses manufacturing and selling cards and gift items.

Teen drivers and Strict Liability in Florida

drivers are a very common occurrence in the

state of Florida. In the state of Florida, parents

have to sign for their teenaged child to receive

a driver's license. The parent of the teen

driver is personally liable in the event of a

motor vehicle accident up to age 18.

Motor vehicle accidents involving teen

Of course, if the teen driver is 18 or older they can enter into a contract to purchase a car and car insurance. If the parent co-signs for the car loan, this doesn't create "liability" under the Dangerous Instrumentality Law of Florida, but this may differ in other states.

However, in Florida the owner of the motor vehicle has primary liability and the driver of the vehicle has secondary liability. As a parent you should consider whether or not you want your teen driver to have good insurance coverage which, of course, costs more for younger drivers. We believe it is important for younger drivers to have adequate insurance coverage so they can recover for uninsured or underinsured claims. Usually it is best to keep teen drivers on the family auto insurance policy.

#### Ask the **Attorneys...**

#### Q: After an accident, should I move my car off the road or leave it at the scene while waiting for the police to arrive ?

This is a common question that many people aren't sure about, Here's what you need to know about moving your vehicle after an accident in order to be safe. First, if you are involved in a crash, you <u>must</u> immediately and safely stop

- your vehicle and check to see if anyone is injured. If someone is injured, call 911 to get help immediately.
- 3 If there are no injuries or only minor ones, you must move the vehicle from
















#### Congratulations To Our Jeffrey Meldon/ TV20 Scholar Athletes of the Week !
