Boating Safety

Boating is a great Florida tradition. From the beautiful dugout canoes of the Seminole tribes to the screaming outboard engines of today's modern fishing boat, people have traveled the waters of this great state for many centuries. Unfortunately, boaters can find themselves in terrible situations when they are stranded and exposed to nature's elements.

Recently, the Florida Fish and Wildlife Conservation Commission has made concerted effort to inform boaters of beacons that can help save lives by transmitting emergency signals via Satellite to Rescue Personnel.

The two major beacons boaters should possess are the Emergency Position-Indicating Radio Beacon (EPIRB) and the Personal Locator Beacon (PLB). The EPIRB is a beacon that is physically attached to the boat and can be automatically or manually activated. The EPIRB can allow rescue personnel to identify the location of your boat in as little as two minutes.

The PLB is registered and can be attached to an individual. These PLBs are waterproof but must be manually activated when held out of water. Many of the PLBs can be attached to life vests in case the boat is submerged and the boater must abandon the vessel.

You can register your EPIRB or PLB at beaconregistration.noaa.gov



Additionally, as of July 1st, 2016, any boat equipped with an EPIRB or boat owner with a PLB will be eligible for reduced recreational vessel registration fees. So make sure you protect yourself and your fellow mates and obtain either a EPIRB or PLB.

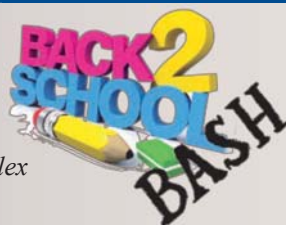

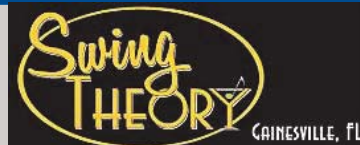

Transportation Safety Checklist

Whether children walk, ride his/her bike or take the bus to school, it is extremely important that they take proper safety precautions. Here are some tips to make sure your child safely travels to school.

Walking to school

⇒ Review your family's walking safety rules.

- Walk on the sidewalk, if one is available. When on a street with no sidewalk, walk facing the traffic.
- Before you cross the street, stop and look left, right and left again to see if cars are coming.
- Never dart out in front of a parked car.
- Practice walking to school with your child. Cross streets at crosswalks when available.

Riding a bicycle to school

⇒ Make sure your child always wears his/her helmet when leaving the house.

⇒ Make sure their helmet is fitted and secured properly.

⇒ Teach your children the rules of the road.

- Ride on the right side of the road, with traffic, and in a single file.
- Come to a complete stop before crossing the street. Walk bike across street.

Riding the bus to school

⇒ Go to the bus stop with your child to teach them the proper way to get on and off the bus.

⇒ Make sure your children stand six feet away (or three giant steps) from the curb.

⇒ If your child and you need to cross the street in front of the bus, walk on the side of the road until you are ten feet ahead of the bus. You always should be able to see the bus driver, and the bus driver always should be able to see you.

This month's topic of interest: **August** 2016

Each month our staff takes a number of calls from people within the North Central Florida Community. We use our clients' comments to come up with ideas for the topics of interest. Here's a topic worth discussing.

INSURANCE COMPANIES FIGHT MAKE UNFAIR SETTLEMENTS

We recently concluded a case where two young people that were injured in a crash that was clearly caused by a non-attentive driver who had a reasonable amount of bodily injury liability coverage. This is the kind of insurance that pays the other party for their past and future medical expenses, past and future loss of income, scarring, pain and suffering and the loss of enjoyment of life.

Our clients were completely reasonable when we sent our demand package to the insurance company to try and settle the case. What happened next is unfortunately typical. The insurance company made two lowball offers to settle the case claiming that:

1. Their insured was not at fault.
2. Even if she was at fault the injuries were not caused by the crash.
3. Even if their insured was at fault and caused the injuries the medical bills were too high, etc etc etc.

They started out offering **\$628.84** on one case and **\$1,755.86** on the other case. We had to file a lawsuit and spend a great deal of time and money needlessly, and only then on the eve of trial did the insurance company pony up settlements of \$31,250 and \$43,750! These are not huge settlements for Meldon Law, but only after our determined effort to make the insurance company do the right thing would they make reasonable offers to settle. Unfortunately, this happens all too frequently.

The insurance industry pays 3.7 times more to settle a case if you are represented by an attorney. They pay even more if you are represented by an attorney who will not fold up the tent and settle for some minimal offer. We know that the insurance companies keep track of which law firms fight for their clients and which ones do not. So when choosing a law firm to represent you, don't always pick the law firm that advertises the most; choose the law firm that you **TRUST**! That's it in a nutshell. Go to battle with someone who is willing to fight for you when the time is right!

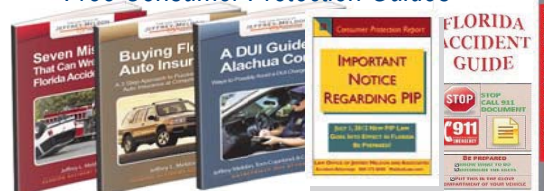
