Christopher Columbus was historically significant...

Columbus Day, October 10, 2011, is a U.S. holiday that commemorates the landing of Christopher Columbus in the New World on October 12, 1492. Columbus' four transatlantic voyages opened the way for European exploration, exploitation, and colonization of the Americas. Columbus did not set foot on the American mainland until his third voyage in 1498 to Venezuela.

In 1937, President Roosevelt proclaimed Columbus Day a national holiday, largely as a result of intense lobbying by the Knights of Columbus, an influential Catholic fraternal benefits organization. Was this a good thing?

- Opposition to Columbus Day dates back to the 19th century when anti-immigrant groups in the U.S. rejected the holiday because of its association with Catholicism.
- Native Americans and other groups have protested the celebration of an event that indirectly resulted in the colonization of the Americans and the death of millions.
- European settlers brought a host of infectious diseases, including small pox and influenza, that decimated indigenous populations.



• **Upon arriving in the Bahamas,** Columbus and his men forced the native peoples into slavery and imposed barbaric forms of punishment, including torture.

Columbus and Columbus Day are controversial. However, from any perspective, one point cannot be argued—Columbus was historically significant.

Every week, about 2 children are fatally rolled-over and another 50 are injured. Children five years and younger are at risk, with the majority of victims ranging from 12 to 23months.

It is that time of year—The Jeffrey Meldon/TV 20 Scholar Athlete Program—celebrating its 15th year!

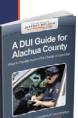

3 Safety Tips for Sharing the Road With Trucks

Florida ranks third for fatal truck accidents behind California and Texas. According to the Federal Motor Carrier Safety Administration (FMCSA), drivers of cars made mistakes in 70% of these accidents. Accidents involving large trucks are generally devastating. The truck driver often walks away without a scratch, while motorists suffer severe injuries or death. Knowing how to share the road with trucks, especially large semis, is essential for your safety. Here are three tips to keep in mind when driving near large trucks:

- **1. Do not cut off a truck**. It takes twice as long for a truck to stop or slow down than a car. The FMCSA states that more than 60% of fatal truck accidents involve the front of the truck. If you need to get in front of a truck, make sure you can see the entire front of the truck in your rear-view mirror.
- **2. Do not tailgate.** Leave enough room between your car and the truck in front of you ,in the event the truck brakes abruptly. In addition, there could be debris ahead on the road, which you will not see, if you are driving too closely. Trucks do not have the same energy absorbing bumpers as cars.
- **3. Stay away from blind spots.** Large semis are almost as wide as the lane they are driving in and many times the length of other vehicles on the road. This gives trucks huge blind spots in front of them, behind them, and on both sides. <u>If you cannot see the truck driver's face in their side-view mirror, they cannot see you.</u> Trucks often have to react quickly to avoid emergencies, making it vital that you are not traveling in the truck's blind spot.

Ask Jeffrey: "I was just in a car crash. What should I do?"

Q: Yesterday, I was T-boned by someone running a stop sign. What should I do now?

Nobody plans on getting in an accident, but when it happens it is important to know what to do A: and what not do.

What to do:

- If you are injured, even minimally, and did not go to the doctor or emergency room yesterday it is important that you seek medical care today or as soon as possible. It is best to go to a doctor who has experience in treating accident injuries. Follow their advice and do not miss follow-up appointments. Note: Sometimes, what seems like a minor injury can turn out to be serious.
- **Notify** your insurance company, if you have not already done so.

What not to do:

- Do not exaggerate or minimize the extent of your symptoms to your medical care provider.
- Do not talk with the other person's insurance company or sign any insurance company documents, papers, or medial authorizations without first consulting an accident lawyer.
