#### Belinda's Beatific Breakfast Bowl

#### Ingredients:

- 1/2 lb bacon
- 1 lb sausage links
- 2 tbsp olive oil
- 6-8 red potatoes
- 10 eggs
- 8 oz bag of shredded cheese



## <u>Here's how to make this early morning meal:</u>

- 1) Preheat oven 400 degrees.
- 2) Spread bacon out on lined baking pan.
- Spread sausage links out on lined baking pan.
- Cook bacon and sausage in the oven until done. Be sure to turn sausage halfway through cook time!
- Once done let meat cool then prepare to chop
- 3) Heat a medium skillet over medium heat.
- Add the olive oil.
- Cook the potatoes until tender.
- Transfer potatoes onto baking sheet.
- 4) Add 1 tbsp of olive oil to medium skillet.

- Scramble the eggs.
- Once eggs are fully cooked remove from heat.
- 5) Combine all ingredients and add cheese to the top.
