Mr. Conner suffered a concussion from either an explosion or a grenade in the line of battle that resulted in him getting air lifted to a hospital in Guam. After spending time in the hospital in Guam, he was sent back to his home in North Carolina. For that injury he earned himself a **Purple Heart**, which he still keeps close to him.






Don recounting his time served.

Stefany's Gramma's Italian Chicken Soup

Whether you have a cold, flu or just need a cozy, simple soup to relax with, this recipe is the cure. I grew up loving this soup and still make it for my family.

Ingredients:

- Whole chicken
- Celery 4 stalks and leaves chopped
- Carrots 3 whole carrots sliced thinly or grated
- 1 large can of tomato sauce
- 1 medium can diced tomatoes
- 1 box Ditalini pasta (or other small pasta)
- Water
- Salt
- r oppor
- Garlic powder
- Fresh Parsley chopped (optional)
- 1 bay leaf
- Grated Locatelli or parmesan cheese

What to do:

- Remove any innards from the chicken.
- Put the whole chicken in a large stock pot and cover it with water.
- 3) Add salt, pepper and garlic powder to the water.
- Boil the chicken for approximately one hour (turning if necessary to avoid scorching the bottom of the chicken).
- Remove the chicken from the water and set aside in a bowl (Be careful. It will try to fall apart).
- 6) Remove any remnants of the chicken (bone, skin etc.) from the water. You should have a good amount of chicken stock left in the pot.
- Add the tomato sauce, diced tomatoes, celery, carrots and bay leaf.
- 8) Add 2-3 cups of water.
- Bring to a rolling boil and then reduce to low/ medium heat.
- 10) Remove all meat from the chicken in bite size pieces and add it to the soup.
- 11) Cook the soup for at least one hour.
- 12) Cook the pasta as directed on the package.
- 13) Drain and set aside.
- 14) Remove the bay leaf from the soup.
- 15) Enjoy!
