

Stefany's Pan Chicken and Vegetables



This recipe is quick, easy and inexpensive! The fun part is getting creative with your vegetables and your spices. My recipe uses potatoes, carrots, green beans and onion – but you can use Brussel sprouts, peppers, mushrooms, broccoli – even sweet potatoes!

Ingredients:

- 4-6 boneless skinless chicken thighs
- 4 russet potatoes peeled and cut into bite sized pieces
- 5 carrots peeled and cut into one inch pieces
- 1 medium onion cut into chunky
- 2 handfuls fresh green beans ends
- Vegetable oil for tossing (about 1/4
- Garlic Salt Pepper Paprika Basil – Cumin (or any spices you
- Non-Stick cooking spray

What to do:

- 1) Preheat oven to 400 degrees.
- 2) Spray a cookie sheet with non-stick spray.
- 3) Combine all of the vegetables in a bowl.
- 4) Drizzle the oil over the vegetables.
- 5) Season the vegetables with the spices (as little or as much as you want).
- 6) Toss to coat the vegetables.
- Spoon the vegetables onto the pan and spread evenly (don't dump extra oil onto the pan).
- 8) Put the chicken into the bowl and toss around in the remaining oil.
- 9) Season the chicken with the spices.
- 10) Lay the pieces of chicken in the middle of the pan (directly on the pan or over the vegetables).
- 11) Bake for 50 minutes.
- 12) Enjoy!


