JEFFREY VISITS THE PANAMA CANAL

One of the Seven Engineering Wonders of the World

I had the pleasure to travel to Panama in April for a wedding and got to experience an afternoon watching and learning about the Panama Canal. When completed in 1914, it was perhaps the greatest engineering masterpiece of its time. The concept of the Panama Canal dated back to the 1500's when Spain wanted to have shorter trade routes to Peru and the west coast of South America. Sailing around the southern tip of South America at Cape Horn was both time consuming and extremely treacherous.

The original design was to have a sea level canal but that proved to be

impossible. The final design was to create a series of locks to lift boats up 85 ft above sea level to a man made lake called Gatun Lake. Ships are lifted up going in and lifted down going out. The 51 mile route takes 11.38 hours to complete. A new super wide/deep set of locks were completed in 2016 in order to handle the huge super ships that have thousands of containers. It costs \$450,000 for a ship with 4,500 containers to cross the Panama Canal. There are approximately 20,000 ship crossings per year. Over 22,000 lives were lost to malaria and

accidents during the earliest construction of the Canal by the French in the 1880's. When the United States took over construction of the canal in 1903, it took 11 years and cost an additional 5,600 lives to complete. Dr. Walter Reed was part of the medical team that devised a way to minimize the risks from malaria and other diseases.

I had no idea how amazing it would be to see the scope and size of the Panama Canal until I spent a few hours drinking cold beers and cocktails watching the Miraflores Locks raise and lower huge ships as they passed through this true Wonder of the World.



Stefany's Classic Best Ever Buckeyes

Ingredients:

- 1 1/2 Cups of Peanut Butter
- 1 Cup Butter, Softened
- 1/2 Teaspoon Vanilla Extract
- 6 Cups of Confectioner's Sugar
- 4 Cups Semi Sweet Chocolate Chips

Directions:

- 1. In a large bowl, mix together the peanut butter, butter, vanilla and confectioners' sugar. The dough will look dry. Roll into 1 inch balls and place on a waxed paper-lined cookie sheet.
- 2. Press a toothpick into the top of each ball (to be used later as the handle for dipping) and chill in freezer until firm, about 30 minutes.
- 3. Melt chocolate chips in a double boiler or in a bowl set over a pan of barely simmering water. Stir frequently until smooth.
- 4. Dip frozen peanut butter balls in chocolate holding onto the toothpick. Leave a small portion of peanut butter showing at the top to make them look like Buckeyes. Put back on the cookie sheet and refrigerate until serving.

TIP: Make sure the peanut butter balls are still very cold when dipping in the chocolate or they won't stick properly.

This month's topic of interest: May 2019

Each month our staff takes a number of calls from people within the North Central Florida Community. We use our clients' comments to come up with ideas for the topics of interest. Here's a topic worth discussing.

Who is Liable if I am Injured in a Bus Accident?

We get this question a lot. As with many questions personal injury lawyers field, the answer is: It depends, primarily on the facts of your case. Typically, however, if you have been injured or damaged as a result of a bus accident, there are several parties the experienced team at Meldon Law may look to as having potential liability. We review them in-depth below.

Remember, however, that because <u>Florida is a no-fault insurance state</u>, your <u>Personal Injury Protection insurance</u> coverage may first need to cover the costs of an injury you sustain in a bus accident. Consult an experienced bus accident attorney if you are not sure where to turn to recover compensation for a bus accident injury.

<u>Bus Drivers</u>: Just as with most motor vehicle accidents, it's possible for the driver of a bus involved in a crash to bear liability for injuring others. This may be aggravated if the driver operated the bus while fatigued, while under the influence of drugs or alcohol, or while distracted by a cell phone or other screen device.

Bus Companies/Owners: If the accident involved a private bus (such as a tour bus or long-haul passenger bus), the company that owns and operates the bus may have liability for your injuries. Liability for a bus company can stem from it having hired or failed to properly train a negligent driver, for having failed to maintain a bus in good working condition, or having forced a driver to operate under dangerous road or work conditions. Under Florida law, the owner of any at fault vehicle bears primary liability for damages in a crash.

Drivers/Operators of Other Vehicles:

Sometimes a bus accident happens through no fault of the bus driver or his employer. Instead, the accident may be caused by the driver of some other motor vehicle that collides with, cuts off, or otherwise interferes with the operation of a bus. In these cases, the driver or operator of the other vehicle may be liable for your injuries.



Bus Manufacturers: When a bus takes to the road with an inherent defect in its design or assembly, it poses a risk to everyone on the road. The manufacturer of a defective bus or bus part (such as its tires or brake systems) may have liability to anyone injured in a crash precipitated by the failure of the bus or bus part to perform as intended under normal operating conditions.

Government Entities: If a government entity responsible for maintaining safe and clear roads fails in its duties, that entity may have liability to anyone injured as a result. A bus crash could easily occur, for example, if a county road authority fails to warn of closure of a road due to flooding or storm damage. Additionally, if a government entity owns and operates the bus involved in a crash, that entity may have liability in the same manner a private bus operator can.
