MOTORCYCLIST CRASH RESULTS IN MULTI-MILLION SETTLEMENT

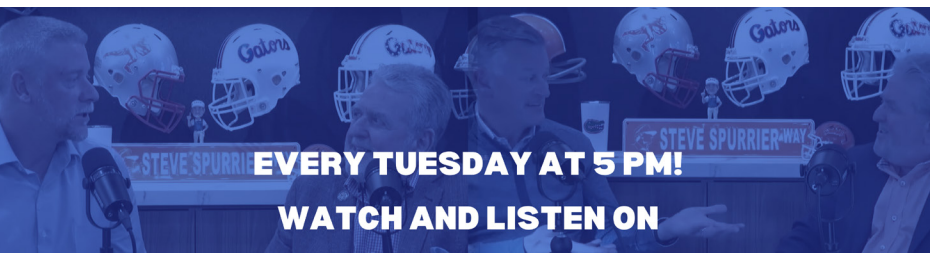
