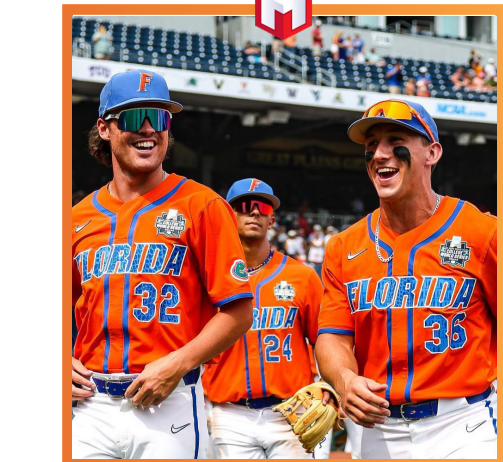

RECIPE OF THE MONTH - BRITTANY'S CHOCOLATE CHIP COOKIES

INGREDIENTS:

- 2 1/2 cups all-purpose flour
- 1 heaping tsp baking soda
- 1/2 tsp sea salt
- 8 tablespoons unsalted butter (room temperature)
- 2 cups packed light brown sugar
- 2 large eggs
- 1 1/2 tsp vanilla extract
- 2 cups semisweet chocolate chips



DIRECTIONS:

1. Preheat oven to 350°, position rack in center of oven, and line a baking sheet with parchment paper.
2. Whisk together flour, baking soda, and sea salt. Set aside.
3. In stand mixer or with a hand mixer, beat butter and sugar until well combined (about 2-3 minutes)
4. Add eggs and vanilla extract to the butter/sugar mixture and beat until blended.
5. Add the flour mixture. Mix on medium until flour is mixed in, then mix on high for 5 seconds to pull the dough together.
6. Add chocolate chips and mix on high for 5 seconds.
7. Drop large spoonfuls on the baking sheet. Do not flatten them.
8. Bake until lightly browned on top, about 10-12 minutes. Let cool on pan on rack for one minute then transfer cookies to rack. Let cool completely.
9. Repeat with remaining dough. Makes about 24 cookies.
